Power exercised by the Lessor under this lease agreement may be exercised by the Director, Rajasthan State Industrial Development & Investment Corporation such other person (s) authorised in this behalf.

At the expression Managing Director shall include the person who is entrusted or with the functions similar to those of the Managing Director.

In difference or litigation touching or arising out or in respect of this Agreement subject matter thereof shall be referred to the sole arbitration to the Collector of Jhalawar or any person appointed by him, the decision of which shall be final and binding on the parties.

Registration charges on this Agreement shall be borne by the Lessee.

ceed 25% of the rent payable for the period immediately preceding revision. The quantum of rent determined by the Corporation shall be final, conclusive and binding on the lessee and it shall not be questioned in any court of law or otherwise.

Provided further that in case the Lessee creates charge in favour of the State Government or Industrial Finance Corporation of India or Rajasthan Financial Corporation or Scheduled Banks for any development loan taken by him on the security of the premises hereby demised and the building and machineries is built upon or affixed thereto, the first charge of the Lessor shall rank Second to the charge of the State Government or Industrial Finance Corporation of India or Rajasthan Financial Corporation, I.D.B.I. or I.C.I.C.I., L.I.C., IRBI, HDFC, SIDBI, Central Co-operative Banks, Private lending agencies and other Public financial institutions as defined in the Public Financial Institutions Act or Scheduled Banks, provided the State Government or Industrial Finance Corporation of India or Rajasthan Financial Corporation or Scheduled Banks keep a specific clause in their mortgage deed that breach of any of the conditions of these presents (Lease Agreement) shall be treated as a breach of the conditions of their mortgage deed.

Provided however, that the above provision shall not operate where sheds are constructed on the demised premises on hire purchase basis by the Corporation. In such cases, the Lessee could create second charge in favour of State Government or Industrial Finance Corporation of India or Rajasthan Financial Corporation or I.D.B.I. or ICICI or L.I.C., IRBI, HDFC

Collateral security plots for loans to other industrial units would be allowed subject to ensur-

- (a) That the Lessee has cleared all the outstanding dues of the Corporation;
- (b) That in case there is a condition of collateral security in the sanction letter of the concerned financial institution, Bank etc. such collateral security may be allowed to be created in favour of parties named in proviso to clause 1 of our Lease Agreement only and not in favour of any other party.

THE LESSEE DOETH HEREBY CVENANT WITH THE LESSOR IN THE MANNER  
WING:

That the Lessee will bear, pay and discharge all rates, taxes, charges and assessment of every description which may, during the said term, be assessed, charged or imposed upon either on the landlord or tenant or the occupier in respect of the demised premises or the building to be erected thereupon.

The lessee shall pay the development charges of the plot calculated at the rate prescribed by the Corporation for Industrial Area from time to time. The Corporation reserves right to enhance the rate of development charges if the compensation payable under an award is enhanced by any competent court subsequently.
