

1. The name of the trust shall always be "KRISHNA YOGA ASHRAM".
2. The office of the trust shall be at Sudyoga Surat Singh Estate, S.V. Road Jageshwarlal Patel, BOMBAY-400 102, or as may be determined by the trustees from time to time and there shall be branch offices or representatives of the Trust at such place or places as may be determined by the trustees from time to time.
3. The trustees shall irrespective of sex, caste, creed or religion held the said sum of Rs. 10,000/-, in cash paid to them by settlor on or before the execution of these presents as hereinabove stated and all contributions collections and donations hereafter to be paid to and received by them from any person and income thereof and any other moveable or immoveable property whatsoever which may hereafter come to or belong to the said trust (all which are hereinafter for the sake of brevity collectively called "The Trust Property") and Trusts for charitable or educational objects and purposes including relief to the poor, education, medical relief, promotion of science art and literature and the advancement of any other object of general public utility.

It is hereby provided that the system adopted for the purpose of medical relief be primarily Ayurvedic yet allopathy, Homeopathy or any other may be introduced as the trustees may deem fit and proper having in view the means and resources at the disposal of the trust.

If any person shall at any time hereafter offer to add to the Charitable fund hereby settled whether by transfer of any immovable or moveable property or Government or other securities, or payment of cash in aid of any of the objects of the Charity, hereby established, it shall be lawful for the Trustees to accept the same upon such terms and conditions NOT INCONSISTENT WITH ANY OF THE OBJECTS of the Trust as the said trustees may determine provided however, that in no case shall the name of the trust hereby created be altered in any manner whatsoever of its declared aims and objects.

5). The Trustees will be at liberty to disseminate treatment of diseases in the public with the help of public meetings, conferences, lectures, pamphlets, books, radio, cinema, slides, handbills and other via media, not mentioned herein.

The trustees will be at liberty to construct, maintain and armange Child and Adult Welfare Centres, recreation centre foci, centres, Shramadan Centres and to organise, maintain and conduct thereof including for the treatment of mental diseases further that propagation of clean living will be encouraged by taking up the issues with the Government, by organising "Peoples' Vigilance Fronts" and interalia preserving set identification marks.

The trustee shall out of the income of the trust pay all reasonable charges and expenses.
