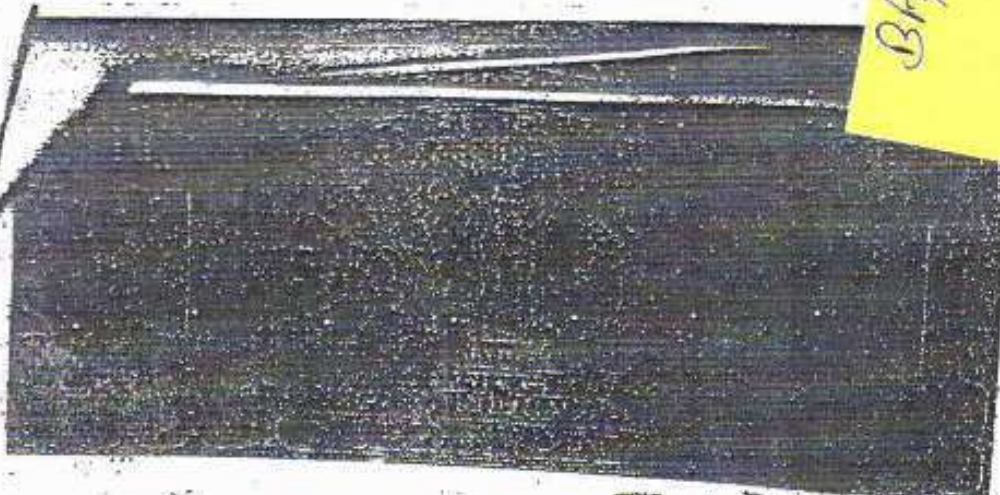

THIS INDENTURE made at Bombay this 9th day of November in the Christian year One thousand nine hundred ~~eighty~~ Eighty Nine between Shri Pratap ~~Sharma~~ of Bombay, the Indian inhabitants hereafter referred to as the "Settlor" (which expression shall unless it be repugnant to the context or meaning thereof mean and include their successors and assigns) of the part and -

1. Shri Pratap Singh
2. Shri R.L. Kabra
3. Sr. Girdharilal Sharma
4. Shri L.V. Subramaniam
5. Shri Indraraj yadav

1) of Indian inhabitant hereafter referred to as the "Trustees" which expression shall unless it is repugnant to the context or meaning thereof mean and include the Survivors or Survivor of them and heirs executor and administrators of the last Survivor and of these presents for the time being of these presents of the other Trustees or trustees for the time being of these presents of the other part WHEREAS the Settlor is desirous of creating a trust of a sum of Rs. 1,000/- (Rupees One thousand only) which the settlor here contributed for charitable and educational object or purposes hereafter referred AND WHEREAS in order to effectuate the said desire, the settlor has agreed to pay deliver Rs. 1,000/- (Rupees one thousand only) and transfer the said money viz. the sum of Rs. 1,000/- (Rupees one thousand only) in cash to the trustees on or before the execution of these presents on trusts and subject to the provisions, covenants, conditions hereafter declared and contained and concerning the same. The Trustees have agreed to act as first trustees of the trust and WHEREAS the Settlor have handed over to the trustees on or before the execution of these presents the said sum of Rs. 1,000/- (Rupees one

6) It is hereby provided that the system adopted for the purpose of medical relief be primarily Ayurvedic yet allopathy, Unani, Homeopathy, Naturopathy or any other may be introduced as the trustees may deem fit and proper having in view the means and resources at the disposal of the trust.

7) If any person shall at any time hereafter offer to add to the Charitable fund hereby settled whether by transfer of any movable or moveable property or Government or other securities or payment of cash in aid of any of the objects of the Charity hereby established, it shall be lawful for the Trustees to accept the same upon such terms and conditions NOT INCONSISTENT WITH ANY OF THE OBJECTS of the Trust as the said trustees may determine provided however, that in no case shall the date of the trust hereby created be altered in any manner whatsoever of its declared aims and objects departed from.

8) The trustees will be at liberty to discriminate treatment of diseases in the public with the help of public meetings, conferences, lectures, pamphlets, books, radio, cinema, slides, handbills and other vis media, not mentioned herein.

9) The trustees will be at liberty to construct, maintain and or manage child and Adult welfare centres, recreation centre, yoga centres, Shramada, Centres and to organize, maintain and conduct branches thereof including for the treatment of mental diseases.
